



- Contact us to make arrangements to pay the balance.


If you have already filed this tax return, please do the following:

- · Send us a copy of it,
- · Sign it or re-sign it,
- · Date it, and
- Allow 6 to 8 weeks to process your return.

If you are due a refund, you must do the following:

- File within 3 years of the original due date of the tax return, or
- File within 2 years from the date the tax was paid, whichever is later.


I accept your offer to require of me an information return for the year in question upon proof of claim that I had any taxable and reported income for that year.




I look forward to your response, as it is my intent to resolve this matter in compliance with the law.
